Interstate Engineering Report: Randy Pope presents the Water Project 14-1 will be in three phases. First phase will be dealing with the new well and updating the other two wells. Completion date is set for October 30, 2015. Phase two will be the water Treatment/Transmission line work including new filter installed and to make a new third filter system. The project complete date is set for November 1, 2016. Third phase is to paint the elevated tank and recoding. The base of the tower will be black with a white top and lettering and the bobcat logo will be in black also. The completion date on this potion will be October 1, 2015. First motion was for the resolution approving the project 14-1. (Linda/ Chris) The second motion was to direct Jessica to advertise for the bids to be opened on Friday, May 8th at 11am. (ElRoy, Linda) Sewer Project 14-2 is still going forward with no updates at this time.

Law Enforcement Report: Dave Kozok reported that there were 6 arrests made in town, a couple of minors, working on some drug cases, and on Wednesday will be the active shooter drill at the NS school. The council directed Dave to take a look at the parking issues in front of Kenny and Faye Waloch's residents. There have also been some issues with four wheelers in town and have been writing citations for them.

Spring's Report: Report handed out. Looking for a club manager, in the meantime, Jeff Anderson is helping out. Security system will be installed with 12 cameras and motion sensors through Dickey Rural. It would be a one-time fee of \$3800 with an additional monthly cost of \$50 to upgrade the phone system to monitor the system.

Flood Home: Tan and Brick house is for sale for \$275,000. House movers have a flood house for sale and Dan will go look at it to see if it is something that would fit in Gwinner.

Housing Study: The housing study came back very positive. We are in need of housing. They recommended an apartment complex for 24 to 28 units, which could be filled within six months of completion. City council would like to work with GCDC to get this this going. Grover will bring this to the GCDC meeting and see when the two groups can get together. **2nd Reading on the Sewer Rate:** Residential base rate \$13.62, Commercial base rate \$19.79 and Bobcat base rate \$3518.99. The over usage charge will be \$.50 per each 1000 gallons usage fee. Projected revenue increase should be around \$28,098.90 (Chris/EIRoy)

Auditor Report: Pet Clinic will be held on April 15th from 4-6pm at the EMS Center on the east side, Cleaning lady, Janet Birchem, at the same rate as the previous cleaner, started on March 11th (Linda/Chris), Equalization meeting will be on April 15th with Sandra Hanson, Jessica will be sending Sargent County a letter letting them know the TIF has ended. Harold Rotunda asked the council to clean up some accounts on the books: Account #300 Childcare Center with the balance of \$16,627.17 will be paid from the Host Fund Account #400 (Chris/ ElRoy), Account #507 EMS Building Construction with a payment of \$32,883 will be paid from the Sales Tax Fund #203 (Chris/ Linda)

Public Works Report: Water issues have been ongoing. The connecting section between pump and motor has completely corroded away. Residents are still experiencing tree root problems throughout the city especially in Maplewood Drive. Our lift stations are still being over taxed with shop rags and other none degradable materials. Both main lift #1 and main lift #2 pumps have been repaired. To recondition a pump the cost is \$5231.00. Council tabled at this time.

Special Assessment Committee: Mayor Dan McKeever appointed Jason Nelson to the special assessment committee and to remove Chris Federer from that committee due to being on the city council.
